The Organization began operations to install wells in the communities of South Sudan in 2005. In 2020-21, the organization shifted to funding the new Water for South Sudan Foundation in South Sudan, which is now implementing the work. In 2020-21, the organization funded the drilling of 48 new wells, impacting more than 35,000 people every day in: 37 communities, 10 primary health care clinics (PHCCs), and 4 schools, including one water storage project in Pinydit. The Organization funded the rehabilitation of 48 older wells, ensuring that the flow of precious clean water does not stop. The Organization also supported 99 hygiene education training programs, with 728 individuals trained on basic safe hygiene practices. (Continued on Schedule O)
